



A LITTLE OF THE FINEPRINT INDEMNITY, WAIVER & DISCLAIMER

Cork and Canvas (Pty) Ltd t/a Red Cliff Lodge ('Red Cliff') Portion 2 of the Farm Bokkraal, Groot Marico ('the Premises')

This indemnity applies to all persons who enter the Premises, whether as casual visitor, overnight guest, user of any of the facilities on the Premises or participating in any activity on the Premises or arranged by Red Cliff (collectively referred to as 'the Visitor')

The Visitor acknowledges that he/she has read & understands this indemnity & agrees to be bound by the following:

- I enter and use the Premises, parking areas, surrounds, stairs on the Premises & participate in any activities at the Premises entirely at my own risk
- Right of admission is reserved.
- I warrant that I have been advised of & am aware of & accept that I will be exposed to a variety of risks & dangers at the Premises which have been explained to me in detail & that I comprehend the risk & the implications thereof.
- Such risks and activities include without limitation pools, ponds, rivers, recreational areas, baboons and monkeys as well as snakes and other wildlife.
- I agree to obey at all times any warning notices and instructions of the management of Red Cliff.
- Visitors hold harmless and indemnify the owners, management, staff, directors of Red Cliff and other guests ('the Indemnified Parties') against any consequences of visiting, participating in any activities or incidents at or arranged by Red Cliff and waive any claims they may have.
- It includes any loss of/damage to personal effects/property, any indirect, consequential or special loss/damage, financial loss, illness, injury, harm (as defined in the CPA) or death howsoever caused & legal costs (attorney & own client scale) that the Indemnified Parties may incur, unless such claim falls within the ambit of section 61 of the CPA (Act 68/2008).
- I undertake to pay any damages to the property caused by myself, family members or any pets brought onto the property.

I acknowledge that any assistance that the Indemnified Parties may render or arrange is done without any admission or acknowledgement of fault or liability and is acknowledged as a show of empathy & goodwill.

TERMS AND CONDITIONS

We operate on a strictly first come first served basis with accommodation only being reserved once deposit or payment is made.

Breakages and damages

A breakage deposit of R500-00 in cash is required upon check-in. This will be refunded at check-out once the exit inspection has been completed.

Eco-Friendly Practices

The cabin operates off-grid using solar and gas power, minimizing its carbon footprint. Please conserve water and energy during your stay.

Noise and Disturbance

As a requirement for booking accommodation at Red Cliff Lodge, we kindly request all guests to adhere to our strict policy regarding noise and music. In order to maintain the serene ambiance of our natural surroundings and to respect the free-roaming wildlife, we prohibit the playing of loud music or any disruptive noise on the premises.

Smoking Policy

Smoking or vaping **IN** the cabin is strictly prohibited and it is requested that all cigarettes be completely extinguished in the ash-tray provided or in the sand bucket. Please do not throw cigarette butts on the ground or the surrounds. This is to eliminate both runaway fires as well as to preserve our Biosphere.

Braai / Fires

We kindly request guests to be respectful with the supply of wood that is provided. We do understand that guests want to watch a bit of bushveld television however we are required to balance the use of the firewood to manage the ecosystem.

We also request that guests do not throw the ashes from any fires on the ground around the garden or cabin area or down at the river. A steel bucket is supplied for any coals or ashes that we will dispose of safely. This is to ensure that we do not damage any plant life or to prevent runaway fires.

River Pool and Picnic Site and Wallow tub

Caution needs to be exercised at the river pool as this pool is deep
It is recommended that only experienced persons enter the deep section of the pool close to the cascade.

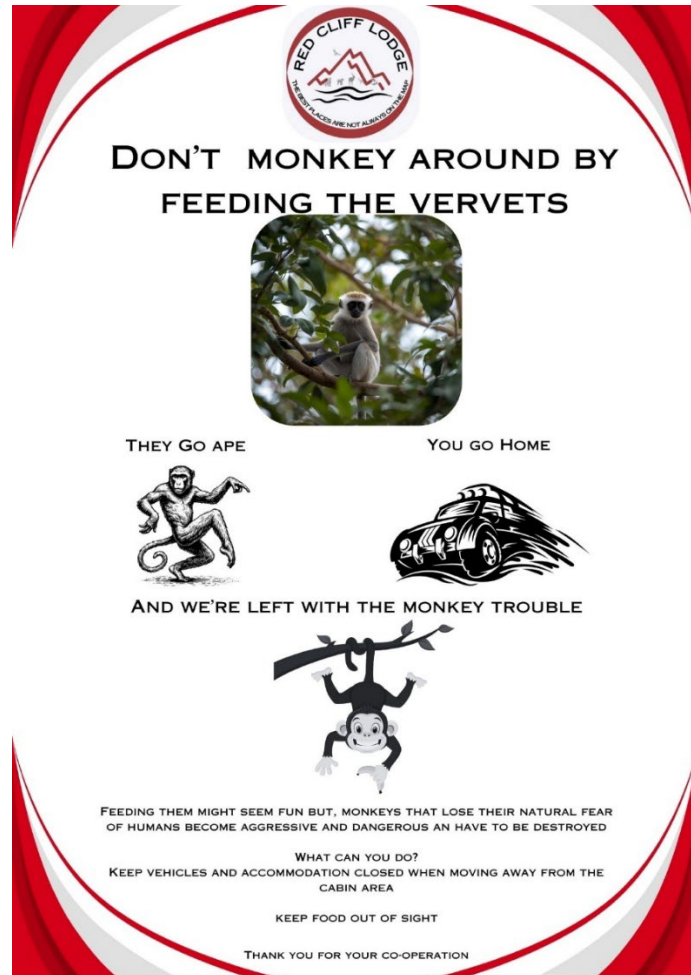
A picnic basket is provided with unbreakable cutlery and crockery for use down at the riverside braai area. Do not remove the breakable items from the cabin.

Please do not use glass bottles or glasses from the cabin in the wallow tub. Steel items are provided in the picnic basket for use around the tub.



Wildlife

Kindly take note that we do have Baboons and Vervet Monkeys who are inhabitants of the gorges. We request guests to be cognisant of this and not to leave any loose items or food in open areas. When moving away from the cabin or lapa area please ensure that the cabin door as well as car windows are closed.



General Rules

Small Children are to be supervised at all times for their own safety. We are in the bush and need parents to be aware that there are reptiles active in the summer months.

Please note that the cabin is not serviced so it would be appreciated if you could assist us by not leaving any dirty dishes in the sink as this attracts ants and flies.

We trust that our guests share our commitment to preserving the environment and fostering a peaceful atmosphere for all. Thank you for your co-operation in helping us protect the integrity of our Biosphere Reserve and ensuring an enjoyable experience for everyone.

All guests are also required to sign an Indemnity Form upon arrival.
